Ontario Youth Apprenticeship Program (OYAP) - Level 1 Programs MLTSD Seat Purchase Confirmation Form

School-College-Work Initiative (SCWI) / Dual Credit programs are programs approved by the Ministry of Education that allow students, while they are still in secondary school, to take college courses that count towards both their Ontario Secondary School Diploma (OSSD) and a postsecondary certificate, diploma, or degree, or a Certificate of Apprenticeship. Regional Planning Teams (RPTs) may submit proposals for Level 1 apprenticeship in-school training; however, OYAP students **must have Registered Training Agreements (RTAs)** to be eligible for Ministry of Labour, Training and Skills Development (MLTSD) seat purchase. INSTRUCTIONS TO REGIONAL PLANNING TEAM (RPT): Contact the local MLTSD office to request seat purchase funding. Complete the information in the table on the second page of this document, print the descriptions of the relevant programs from the Ministry of Education's Enhanced Data Collection Solution (EDCS) and attach to this form, and bring them to the local MLTSD office. Once the MLTSD office has signed this form, submit it by email to David Armstrong at davidarmstrong@ontariodirectors.ca. Please note that programs will not be approved without a completed and signed form. Please have a discussion with RPT representative(s) that focuses on approved vs actual student numbers, retention and success in the requested Level 1 program(s). Where the previous year's results are a concern, the discussion may also include strategies to better select and support students AND/OR reducing the approved numbers of students in the Level 1 program. If seat purchase funding is approved, please complete the last two columns of the table – Number of Seats Funded and Total Seat Purchase Funding Amount. If seat purchase funding is not approved, please provide an explanation below.
